<sup>1</sup> If this application is approved by the Parole Board, active parole *supervision* will be terminated, however, termination of *supervision* does not terminate the parole *sentence*. As long as a parolee remains under a sentenced term for which they were issued a parole permit, the permit remains valid, and the Board remains authorized to revoke parole under R.I. General Laws §§13-8-18 –19.1 or 13-8.1-4 for incident of new criminal behavior or serious parole violation.

<sup>2</sup> The term an "incident of new criminal behavior" or "serious parole violation" includes a new arrest or report of a parole violation, if supported by substantial evidence of guilt, even if no conviction or parole revocation results. The parole board shall not terminate supervision until it determines the disposition of a pending criminal charge.
